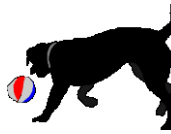

I further agree that I am financially responsible for any medical treatment my dog(s) receives as a result of a medical emergency.

Boarding Service Agreement

This is a contract between ALWAYS ABOUT PETS LLC and dog owner(s) for any service provided here.

Pet Name(s) (1) _____ (2) _____ (3) _____ (4) _____

1. ALWAYS ABOUT PETS LLC has relied upon my representation that my pet is in good health and has not been exposed to rabies, distemper or any other communicable diseases within a 30 day period prior to any stay. I will inform ALWAYS ABOUT PETS LLC of any changes in my pet's condition and behavior at, or prior to, check in for all subsequent boarding stays.
2. My pet(s) is up-to-date on Bordatella Vaccine, Distemper Vaccine, Parvo Vaccine and Rabies vaccine.
3. I understand that ALWAYS ABOUT PETS LLC is not a 24-hour facility. While we do have Security and Fire monitoring around the clock, our Suites are not monitored by personnel between approximately 6pm and 7am. Pets requiring overnight care, or medical monitoring or pills/medications, during these hours, should not board with our facility.
4. I understand that for SAFETY REASONS ONLY, when walked, my pet will be required to be leashed with 2 'locking' slip leads. Larger breeds may be required to wear an adjustable chain collar in addition to one 'locking' slip lead. I understand that this Double leashing method, and type of collar, is to ensure my pet's safety and to prevent my pet's escape and risk of injury.
5. I release ALWAYS ABOUT PETS LLC, and waive all claims and liability against ALWAYS ABOUT PETS LLC for, damage to, or loss of, personal equipment or belongings provided by myself for my pet while my pet is being boarded. Any personal equipment or belongings not picked up within 1 month of check out date will be 'donated' to ALWAYS ABOUT PETS LLC. ALWAYS ABOUT PETS LLC reserves the right to remove, from my pet, any personal equipment or belongings that it deems as a hazard to my pet.
6. ALWAYS ABOUT PETS LLC takes all Boards outdoors to relieve themselves at least 3 times a day (once around 7am, again around Noon, and again around 5:30 pm). However, despite this, there are occasional 'accidents'. While ALWAYS ABOUT PETS LLC does it's best to launder soiled Personal items, I understand that ALWAYS ABOUT PETS LLC is not a laundering facility and that time restraints, or size of item, may not allow for laundering and personal items may be returned soiled.
7. I understand that ALWAYS ABOUT PETS LLC reserves the right to refuse service at its discretion. ALWAYS ABOUT PETS LLC does not board animals with behavior/medical problems that are deemed a safety risk for staff, other boards or itself.
8. My pet has not injured or shown aggression or threatening behavior to any person.
9. I understand that ALWAYS ABOUT PETS LLC reserves the right to separate paired pets into separate Suites (or Crate, if a Suite is not available) if pets are deemed to be a safety risk to each other. ALWAYS ABOUT PETS LLC reserves the right to charge the additional \$2 per night for the separate Suite at their discretion.
10. I understand that ALWAYS ABOUT PETS LLC, their owners, staff, partners and volunteers will not be liable, financially or otherwise for injuries to my pet, myself or any property of mine while my pet is in the care of ALWAYS ABOUT PETS LLC. I hereby release ALWAYS ABOUT PETS LLC of any liability of any kind arising from my pet(s) care in any and all services provided by ALWAYS ABOUT PETS LLC.
11. While ALWAYS ABOUT PETS LLC does it best to prevent the spread of infection, illness or communicable disease, I understand that there is always an inherent risk my pet might contract an infection, illness or

communicable disease from being in close group setting with another pets. I understand that ALWAYS ABOUT PETS LLC, their owners, staff, partners and volunteers will not be liable, financially or otherwise any illnesses, infections and/or communicable disease my pet may contract while my pet is in the care of ALWAYS ABOUT PETS LLC. I hereby release ALWAYS ABOUT PETS LLC of any liability of any kind arising from my pet(s) care in any and all services provided by ALWAYS ABOUT PETS LLC

12. I understand that if my pet is suspected to have an illness, injury or communicable disease, it will be separated immediately from the other boarding dogs and I, or my emergency contact, will be contacted and my pet will be taken to nearest veterinary. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the health of my dog.
13. I understand and agree that any problems with my pet, behavioral, medical or otherwise will be treated as deemed best by the staff of ALWAYS ABOUT PETS LLC in their sole discretion and in what they view as the best interest of the dog. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog.
14. I understand that by allowing ALWAYS ABOUT PETS LLC to care for my pet(s), I hereby agree to allow ALWAYS ABOUT PETS LLC to take photographs or use images of my pet(s) in print form or otherwise for publication and/or promotion.
15. I understand that I am solely responsible, financially and otherwise, for any harm or damage caused by mydog(s) while they are the care of ALWAYS ABOUT PETS LLC.
16. I agree, if my pet shows any signs of fleas or ticks during their stay, that ALWAYS ABOUT PETS may flea dip, and apply flea preventative to, my pet and I will be charged accordingly.
17. I agree that my pet shall not leave Always About Pets' facility until all charges for services rendered are paid in full. Always About Pets LLC shall have, and is hereby granted, a lien on my pet for any and all unpaid charges resulting from services rendered by Always About Pets. If I do not pick up my pet with 7 calendar days after the day the pet was due to be picked up, the pet shall be deemed abandoned. The person whose custody the pet was placed for care shall first try for a period of not less than 14 days to find a new owner for the pet, and, if unable to place the pet with a new owner, the abandoned pet shall thereafter be turned over to a local Animal Shelter.
18. I specifically represent that I am the sole owner of the pet, free and clear of all liens and encumbrances.
19. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and Facility.
20. Any controversy or claim arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled in a Court of Law.
21. By signing this Contract and leaving mypet with Always About Pets LLC, I certify have read and agreed to the above service agreement and to the accuracy of all information given about said pet(s).
